**(a) Reason for change (Re-Appointment):**

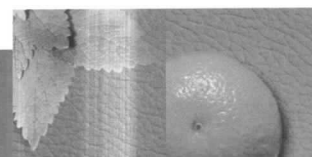

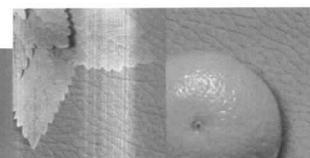
